Desire to move away from google sheets for registration of all things currently in Google sheets (including: Digital Cinema Facilities, Studios, Private ULs, CPL Metadata Extensions, Forensic Marking Flags, ISDCF Class 13 ULs, Language codes, Territory Codes, Territory code mapping, Content types, Content type modifier.

Pierre built an example GitHub registry for the language codes. We showed use of the registry. <https://sandflow.github.io/melt/isdcf.html>

The group was enthusiastic about moving away from google sheets. This approach seems right, but how does ISDCF grow up and have the technical support to build and maintain the registries?

We should include a field in the language field to include its application - since the long term goal is to merge with the bigger list of MESA.

We need to have a method of suggesting changes to the list - allow direct comments via github or via (last option) email to info@xyz.com. Better for the github since it is traceable.

The group agreed that we should start the transition to GitHub for the language codes asap. On the to-do list.

Next issue: Should we move all the other registries to the GitHub approach?

Yep, and some would be willing to pay more in "dues" to fund someone to help make the other registries. We will discuss again next meeting.

There will be image testing Thursday / Friday January 23 / 24 next week. Goal is to determine some of the numbers in the DCI HDR spec.

Update to SMPTE standards - Bv2.1 documentation - RDD submitted

It appears that all attending ISDCF participants are also SMPTE members, so we believe we can discuss the document at this meeting. This document covers all the restrictions that ISDCF's Bv2.1 puts on a package AND other restrictions that

authoring houses have determined to be needed to achieve 99% playable files in deployed systems.

If someone decides to go outside this constraint information, not a hard restriction, but guidelines. The goal is to have a pointer on the ISDCF technical document listing a pointer to this document - free if possible.

If there is a next one ... it may be for high frame rate.

Voting is underway in SMPTE for this RDD

There is a desire to create a new sample DCP that includes these restrictions. ISDCF wants a "free" version to be posted.

Digital Cinema Picture Levels

Next adventure 7am at AMC Burbank Thursday January 23, 2020 We are asking for feedback and suggestions to make the results more valuable.

A short presentation was made on the current status. (posted in meeting notes folder)

Question: should we test mastering and DI suites - YES please!

How much does an iPhone increase the theater black level? About 0.2 to 0.4 mNits. Trying to get a way to understand what 2mNits means. This was a fail, but interesting.

The center brightness is not a good indicator of the quality of the image.

Should we do an A-B a great screen to a gain-screen quality? Interesting possible test.

Trying to establish DCIC to use less fancy detector to measure the black (40mNits for sequential contrast vs DCIC (about a factor of 2 brighter).

What's most important (from Jerry's point of view): 5 point brightness - especially if it's above 10ftL. The theater black - especially if below 4mNits. The DCIC -

especially if above 700. System black (although related to sequential contrast) especially if under 40mNits.

Was projector black measured in other locations than the center.
DCIC is measured left and right averaged.

How does this information compare to SMPTE standards - possible that the SMPTE specifications are far too optimistic. Especially with regard to fall off. (BTW SMPTE may be working on a new recommended practice for measuring screens.)

We have been using on-line google sheets to record the data. We are considering using a real on-line database, but so far we haven't figured out everything we want (so far).
